TRANSNATIONAL EXPERIENTIAL JUDICIAL TRAININGS, IN HYBRID FORMAT, AT THE HELLENIC NATIONAL SCHOOL OF THE JUDICIARY

Transnational trainings were held in November 2021, for trainee and for acting judges and prosecutors from Greece, Spain, Austria and Germany. Over 4 days of training, 114 judges and prosecutors were trained with the active engagement of 13 trainers and speakers.

The aim was to meet the training needs of judges and prosecutors, who wish to participate in cross-border training activities on EU law, but would rather do so in their native language. The training was experiential and interactive, aimed to equip participants with ready-to-use, practical tools on EU Roadmap Directives on access to a lawyer, presumption of innocence, legal aid, procedural safeguards for children who are suspects or accused persons in criminal proceedings; as well as to offer the chance to network and exchange experiences with their peers in their mother tongue. To this end, simultaneous interpretation was provided between Greek, Spanish, German and English.

The training was based on the curriculum and training material designed in the framework of the project and piloted in Greece and Spain.

TRANSNATIONAL PARTICIPATORY JUDICIAL TRAINING ON PROCEDURAL RIGHTS



The methodology and the training material were experiential and practice-oriented, and included case studies on real-life cases of the CJEU and ECtHR, a moot court simulation, as well as role playing exercises on child friendly communication during criminal proceedings, designed and executed by child-psychiatrists.

To assess the effect such trainings have on the professional practice of judicial stakeholders, a thorough evaluation is being held, which will be followed by an ex-post survey.
